MOVING FORWARD ...

As we look back and celebrate our first thirty years serving the economic development needs of Fayette County, we are also embarking on a future path to make Fay-Penn more relevant and effective. In 2020, we engaged Teeter & Associates to assess Fay-Penn's operations and develop a strategic plan focused on key areas and issues where we can have the most impact.

The most significant takeaway from Teeter's findings was the need for Fay-Penn to engage with related organizations and develop strategies and techniques to collaborate and partner. Put simply, Fay-Penn over time had drifted toward working autonomously when we could be far more effective working collaboratively with other economic development and community organizations.

In 2021, we undertook a significant effort to align the organization to implement the strategic priorities listed to the right, with the short and long-term intent to achieve the measurable outcomes identified.

Among the more significant 2021 activities were the following:

- Downsized the Board of Directors to make roles more meaningful, while increasing member engagement by establishing or expanding committees through which members can provide their expertise to the staff and represent Fay-Penn in the community
- Reorganized the staff into teams focusing on Economic Development, Real Estate, Workforce Development and Operations. Staff members' roles have been redefined as necessary to support the strategic priorities, and each member has firm implementation objectives
- Hired an Economic Development Manager and Workforce Development Specialist, both of whom have significant responsibilities to develop and expand relationships within the community, and identify and execute opportunities for collaboration
- Undertook a project to rebrand the organization for the future – fresh, up-to-date logos and style to help usher in the "new" Fay-Penn focused on collaborating to improve the economic well-being of our community

In 2022, we intend to continue focusing on the implementation of strategic objectives, and in 2023 will reconvene the strategic planning committee to assess progress and update the plan as needed.

REAL ESTATE PROJECTS



FAYETTE BUSINESS PARK SPECULATIVE BUILDING – Construction is nearly complete on the new 100,500 sq. ft. speculative building at the Fayette Business Park in Georges Township. The \$7+ million project was financed, in part, with a grant and loans from the Commonwealth of Pennsylvania, Department of Community and Economic Development (DCED) through the Pennsylvania Industrial Development Authority (PIDA) and Business-In-Our-Sites (BOS) programs.

PROPERTY ACQUISITION – Fay-Penn acquired 109 acres of vacant land along Route 119 South and the PA Turnpike 43 in Georges Township for future development.

LAND DEDICATION FOR TURNING LANE – A small tract of land near the entrance of the University Business Park (UBP) was dedicated to PennDOT by Fay-Penn to alleviate turning lane issues to accommodate the location of a new Sheetz convenience store/gas station.



FIRST NATIONAL BANK (FNB) BUSINESS EVENT CENTER IMPROVEMENTS – New air quality system upgrades to introduce 100% fresh outside air into the space, along with a GPS Bi-Polar Ionization, and UV lighting were installed at the 70 seat facility that can be used at no cost to businesses or organizations for events and training.



REAL ESTATE DEVELOPMENT PLANNING – Several studies and planning efforts were commissioned to chart the way for current and future real estate development, i.e.,

- Business Attraction Strategy: Identifying Target Industries
- Springhill Township Property Best Use Study
- Site Development Preliminary A&E Studies

COMPANY PROJECTS

MONTGOMERY MEDICAL - Fay-Penn sold its 10,800 sq. ft. commercial building in the Fayette Business Park, known as Ridgeview Plaza, and an adjacent 2.79 acre lot to Montgomery Medical to accommodate the company's future expansion plans.



ADVANCED ACOUSTIC CONCEPTS (AAC) - Construction began on a 30,500 sq. ft. expansion to an existing 40,730 sq. ft. facility at the University Business Park, North Union Township, owned by Fay-Penn. This \$7 million project, funded in part, with a loan from the Pennsylvania Industrial Development Authority (PIDA), is being undertaken to meet the expansion needs of AAC. The company has been operating in this facility since 2003, and has committed to another 15-year term lease, with the expectation of retaining 120 jobs.

EDGE OVENS - Edge Ovens renewed its 8,000 sq. ft. lease in the North Union Business Center for another year, and acquired a 44,620 sq. ft. building owned by Fay-Penn, referred to as the former Romeo building in North Union Township, to accommodate its business expansion.



COLUMBIA GAS/NISOURCE - Fay-Penn sold its first two lots at the Dunbar Township Business Park (DTBP) to Columbia Gas/NiSource. The company acquired 16 acres and constructed a new 30,000 sq. ft. operations center that is expected to house 30 employees.

SHEETZ - Sheetz acquired a 2.9 acre tract at the entrance of the University Business Park from Fay-Penn. Sheetz began construction of a gas station/convenience store scheduled to open in 2022.



COMPANY PROJECTS



PENNALT ORGANICS, INC. - PennALT was successful in being awarded a \$1.5 million grant from the Commonwealth of Pennsylvania's Redevelopment Assistance Capital Program (RACP) to assist in funding a building expansion. Fay-Penn served as the official grantee for the funding.

BOEING - Boeing extended its facility leases at two Fay-Penn owned facilities, the North Union Business Center and 500 Mountain View Drive in the Fayette Business Park, Georges Township.

HILL INTERNATIONAL - Hill International extended its 1,000 sq. ft. lease at the Eberly Building in the University Business Park for a period of two years.

WESTERN PA BEHAVIORAL HEALTH SERVICES - This medical facility extended its 5,400 sq. ft. lease, and added an additional 2,800 sq. ft. in the Brownsville Plaza multi-tenant facility owned by Fay-Penn for two-five year term renewals.

STOCKTON TREE SERVICE - Stockton Tree Service received professional training at no-cost by utilizing the Fay-Penn Proserv program. Bridgeway Capital Professional Services provided QuickBooks training, marketing skills, etc. to help improve bookkeeping skills.

FAY-PENN REVOLVING LOAN FUND (RLF) PROJECTS

In 2021, four small businesses received \$215,000 in RLF loans. Collectively, these four projects represent \$897,000 in new private investment that is expected to create and retain 22 jobs. The loans were used to assist in financing costs such as building renovations, acquisition of machinery, equipment, furniture and fixtures, inventory, working capital, marketing, etc.

Fay-Penn's \$15 million RLF was established with \$1 million in 1993, and continued to grow with the addition of grants and loans from the US Department of Agriculture, PA Department of Community and Economic Development, County of Fayette, private foundations, and interest reinvestment.

To date, 211 loans have been made totaling \$30.7 million as part of an estimated \$99.5 million in new investment.

SERVICES, INITIATIVES, ACTIVITIES & EVENTS

WORKFORCE DEVELOPMENT - Locating a talented pipeline of candidates has become one of the most important issues facing today's employers. Fay-Penn expanded its focus on workforce needs by adding a Workforce Development Specialist to its staff to partner with relevant stakeholders and assist in helping to develop, promote, and enhance initiatives that will assist employers in finding tools and resources to hire and develop a robust workforce.

During the year, Fay-Penn worked diligently to learn more about the county's workforce needs, uncover and educate employers about currently available resources, and identify gaps to design new programming. Several initiatives were undertaken to help with assessment and identification of needs, including, but not limited to the following:

- A Fayette County Business Survey was conducted in collaboration with the Fayette Chamber of Commerce to determine the number of open job positions. The survey resulted in 137 responses reporting 1,164 job openings.
- A survey with workforce-centric questions was distributed to approximately 50 local employers addressing turnover, expected hiring needs, and how the county is doing in relation to offering incentives, initiatives, programming, and cost savings to help employers in their efforts to grow.
- Local employer visitations, tours, and meetings were conducted.
- A learning series, "Meet. Learn. Grow," developed in partnership with CareerLink™ has been a source of information for employers on many topics such as how to best utilize the services provided by CareerLink™, on-the-job-training, federal bonding, creative job postings, ways to retain employees, and much more.
- Partnership with the Chamber of Commerce was strengthened as new plans and programs are created together.
- "Grow with Google" awarded Fay-Penn with 50-100 scholarships to help those interested in a new career in Information Technology that will be distributed 2022-2023.

Upcoming initiatives include continued educational seminars, growing partnerships and expanding programming with local agencies and organizations, ongoing research to ensure that all is being done to develop a strong pipeline of employees, and generate awareness of career opportunities within the county.




SERVICES, INITIATIVES, ACTIVITIES & EVENTS

ORVILLE AND RUTH EBERLY WORKFORCE DEVELOPMENT FUND

- This scholarship fund was created by Fay-Penn in 2015 in honor of the Eberly family to provide financial assistance to post secondary students who reside in Fayette County and are pursuing a skilled trade/technical vocation at an eligible Fayette County educational institution. The Fund was formed with contributions from Fay-Penn, the Eberly Foundation, and the Community Foundation of Fayette County (CFFC), and continues to grow using the proceeds from Fay-Penn's Annual Membership Meeting Sponsorships.

Fay-Penn chose the CFFC to administer this permanent fund, which informs Fay-Penn each year how much can be distributed based on its value. Fay-Penn then chooses recipient schools who award individual scholarships. In 2021, seven schools were awarded a total of \$9,500 in scholarship funding benefitting 34 students. Since the fund's inception, \$75,250 has been awarded to 198 students. As the fund grows, Fay-Penn hopes to increase the number of scholarships awarded each year; and use the data gathered through our workforce development programs to more closely target schools and programs that graduate skilled employees in the areas of greatest need by employers.

CHIRP GRANT AWARDS



- Fayette County contracted with Fay-Penn to administer the \$1,464,205 Covid-19 Hospitality Industry Recovery Program (CHIRP) funding allocation from the Commonwealth of PA. The program provided grants to businesses in the hospitality industry to assist in alleviating impacts from COVID-19 restrictions. Fay-Penn developed and administered a comprehensive county-wide program resulting in the award of 81 grants. Fay-Penn expresses its gratitude to the state legislators and Fayette County Commissioners for their leadership in implementing this program.



FAYETTE LEADERS ACADEMY (FLA)

- The FLA resumed operations in 2021 with seven participants in the cohort. The team project consisted of a survey of 15-24 year olds in the area to determine what is needed to keep the young people here after graduation and what would be helpful in bringing back the ones that left to pursue employment elsewhere.

The FLA is a joint initiative of Fay-Penn and Penn State Fayette, The Eberly Campus. Since starting in 2015, a total of 45 individuals have graduated from the Fayette Leaders Academy with six additional students slated to complete the program in 2022.





FAYETTE LAUNCHBOX - The Fayette LaunchBox, a joint initiative of Fay-Penn and

Penn State Fayette, The Eberly Campus, is a no-cost business accelerator designed to help regional entrepreneurs and University affiliates develop their ideas into commercially viable products and services.

A virtual LaunchBox Business Pitch Competition was held with five students doing a Zoom presentation of their entrepreneurial ideas. Three students from Penn State Fayette, The Eberly Campus, were awarded prizes for participation in the first-annual Fayette LaunchBox Shark Tank Competition. The competition, which was open to Penn State Fayette affiliates as well as community members, required each entrant to present a brief elevator pitch for a proposed product or service. The winners were awarded stipend prizes ranging from \$500-\$2,000.

A cohort of three students from Penn State Fayette, The Eberly Campus participated in the second-annual mentorship program at the Fayette LaunchBox for six weeks during the summer. The mentorship program, which provides students with microgrants and resources to develop their promising entrepreneurial ideas, is an initiative to generate more technology-based start-ups in the region. The cohort attended workshops at the LaunchBox facilitated by the University and community entrepreneurs, including "What is Crowdfunding?," "The Importance of Digital Marketing," "Entrepreneurial Planning," and "Branding Workshop." Among other things, students also completed "investor-ready" video pitches for entry into the 2021 Penn State Startup competition.

Since opening in 2018, eight students of Penn State, Fayette, The Eberly Campus have received mentorship, microgrants, and access to the Fayette Launchbox to develop their ideas; and five businesses have made their start as tenants in the LaunchBox facility.



FAYETTE MANUFACTURING

CONSORTIUM - In conjunction with the Fayette Chamber of Commerce, Connellsville



Area Chamber of Commerce, and the Mon Valley Alliance, Fay-Penn announced the launch of the Fayette Manufacturing Consortium. The Consortium connects Fayette manufacturers and offers assistance and resources for them to be competitive in a global marketplace, collaborate on enhancing local supply chains, share challenges and best practices, and heighten public awareness of the industry in Fayette County. An event was held in August with three speakers from PennTAP, Catalyst Connection, and the Steel Valley Authority, and attended by 30 businesses either virtually or in person.

PA PREP AND ENGAGE PROGRAMS -

Fay-Penn contacted 25 local companies, provided on-site outreach, one-on-one counseling, specialized workshops, and provided financial incentives through the PA's Partnerships for Regional Performance (PREP) and PA Engage! programs.

SMALL BUSINESS DEVELOPMENT CENTER - Fay-Penn collaborated with the Saint Vincent College Small Business Development Center (SBDC) to guide companies through the business planning process. In 2021, SBDC met with 46 clients that resulted in 15 business plans completed and five business start-ups.
